Somers Explorers and Firefighters Participate in American Lung Association's "Fight for Air Climb"

Members of Somers Explorer Post #463 and Fire and Rescue Department stepped up to the challenge of raising money for the American Lung Association's "Fight for Air Climb" annual fundraiser. The event was held on March 10, 2018 at the US Bank Center in Milwaukee. Eight Explorers climbed up 47 floors (1,034 steps) to earn money from pledges they collected

Our Somers Fire & Rescue Department receives many calls for assistance due to breathing difficulty. Not being able to breathe efficiently is stressful for people and this worth while event supports research in lung health and environmental programs to combat the many causes of difficult breathing.



Roads and Streets

We continue to make major improvements in our aging Village and Town roads and streets. Commencing mid-late summer 2018, \$367,179 of road projects will begin on 113th Avenue and 4th Street, 61st Avenue, 12th Avenue, 82nd Avenue, 63rd Avenue, 10th Place and 10th Street. A second project focusing on 63rd Street will be added in the second half of 2018.

New Stormwater Utility District

On January 23, 2018, the Village Board approved the creation of a new Stormwater Utility District, Ordinance 18-001, which will shift funding of stormwater management from the General Operating Fund to a new Stormwater Utility Fund. The new Utility District is timely as it follows our historic eight inch rainfall on July 11, 2017 where Somers incurred \$230,000 in flood damage. A stormwater utility, as authorized under Wisconsin Statutes, allows municipalities to create a system for collecting, transporting, pumping, treating or disposing of stormwater.

Water Main Project

In January 2018, we completed a one-year \$3.6 million water main project. The new main extends from Highway L and 41st Street west to Highway H. It supports additional fire protection to the First Park 94 industrial campus located on Highways H and S. 80% of the cost is funded by First Park 94.

Sanitary Sewer Rehabilitation Project

In March 2018 a \$376,302 contract was awarded to line or replace old aging clay sewer laterals that connect sewer service from the road to resident homes. Many laterals date back to the 1950's and have problems with cracked pipes, leaking joints, roots, and holes that cause improperly ground water infiltration. Work is currently in process on 52nd Avenue with 16th Place to follow. Work in the following years will focus on the Sheridan Road corridor.

New Water Study

In conjunction with the Kenosha Water Utility, a 2018 water study will address future water demands on our water system that will be triggered by changes in land use and development.

Public Works Equipment

A new sewer utility service truck has ordered and shall replace an aged truck which will reduce maintenance costs and eliminate reliability issues.

Public Safety

New public safety equipment has been purchased for rescue workers and firefighters. Additionally, effective April, 2018, a full-time firefighter/paramedic has been hired to replace a seven-year vacancy in full-time staffing. Adam Pisula's extensive qualifications and experience includes Wisconsin EMT/Paramedic license and Certified Firefighter II level as well as Certified Fire Inspector.

I-94 Corridor Land Use Study

This study will outline possible new future land uses for the I-94 corridor. A new proposed 2050 land use plan will address market trends, new boundary agreements, and infrastructure needs resulting from the Foxconn development on our north border and I-94. Thank you to the over 100 people who attended and voiced their opinions at the May 1, 2018 listening session.

I-94 Exit/Entrance Ramp Changes Now until Thanksgiving

Coming from Chicago north to Somers: exit ramp to Hwy. E eastbound open.

Coming from Milwaukee south to Somers: must use exit ramp on Hwy.142 or Hwy. 20 in Racine. Proceed to Hwy. E on county roads.

Driving to Chicago south: Hwy. E southbound entrance ramp open.

Driving to Milwaukee north: Proceed on county roads to entrance ramps on Hwy. 142 or Hwy. 20 in Racine.

Exit and entrance ramps for Hwy KR and Hwy 11—closed north and southbound.

Special Information About Highway KR Potential Railroad Overpasses

- This area is currently in the "design" phase
- 60% of the preliminary design planning is expected to be completed by November 1, 2018
- Phase II construction is expected to begin 2021

Property owners along or near Highway KR east of Highway H are **STRONGLY ENCOURAGED** to voice their concerns and ask questions relating to their specific parcel **NOW**.



WE Energies Adds Second Transformer in Somers Doubles Capacity

WE Energies will add a second transformer substation on land owned by the University of Wisconsin-Parkside on Berryville Road (Highway A) just west of 22nd Avenue. Built in 2000, the original substation has

experienced 4% annual load growth. Adding the second substation within the current easement area is a proactive move that will serve as a backup to restore power in the event of an outage, and it will double future service capacity needs as Somers experiences future development. The request for a Conditional Use Permit for the expansion of an existing electric utility substation was approved by the Village Board on April 24, 2018.

HIGH ANGLE RESCUE

Somers Fire & Rescue responded to a person who had fallen down a steep Lake Michigan embankment when the edge broke away, causing a fall of ten feet with a total distance to the bottom of 20 feet. Unable to climb back up, a Kenosha County Technical Rescue Team who specializes in high angle rescues responded as well as Somers ladder truck #6331 with special equipment. The person, who was hoisted up using ropes, pulleys, harnesses and other equipment, was rescued safely with very minor injuries.

Please use caution when walking near the edge of Lake Michigan bluffs as there may be little support under the edge.

Somers Attends Convention Seeking Retail Development
